

LINCOLN COUNTY FOREST ANNUAL WORK PLAN 2010

TO: THE LINCOLN COUNTY FORESTRY, LAND AND PARKS DEPARTMENT
COMMITTEE AND HONORABLE SUPERVISORS OF THE LINCOLN COUNTY
BOARD

Following is the proposed Lincoln County Forest work plan for the year 2010. The plan gives direction and meaning to the proposed County Forest budget. The plan further defines and supplements the Fifteen-Year Comprehensive Land Use Plan and emphasizes the current needs of the County Forest and Recreational System.

TIMBER HARVEST

Timber harvests are not only important for the economic well being of Lincoln County, but for the health and vigor of the forest. This includes all aspects of the forest; wildlife, watershed protection, air quality, recreation, and other noncommercial values. Professional implementation of proper forest management and harvest techniques is essential. The timber management goal is to produce a sustained yield of forest products by scheduling timber sales to achieve the average annual allowable cut. Compartment reconnaissance information from schedule 12B will be used to determine stands where timber cutting is needed. When harvesting in these sales takes place, inspections and reports will be filed as needed and as required by Sustainable Forestry Initiative (SFI) and Forest Stewardship Council (FSC) Forest Certification. The Lincoln County Forest became SFI certified in March of 2005 and FSC certified in July of 2007. Lincoln County Forest plans to offer for sale approximately 2,100 acres for harvest in the following timber types in 2010:

Northern Hardwoods	<u>1000</u> Acres
Aspen	<u>900</u> Acres
Red Pine	<u>100</u> Acres
Other Species as Needed (to include Fir-Spruce)	<u>100</u> Acres

- A. Pre-Harvest Scarification: None planned
- B. Site Preparation: 15 Acres (Brush Raking & Patch Scarification)
- C. Aspen Regeneration: 900 Acres
- D. Plantings: 15 Acres
- E. White Birch Regeneration: 40 Acres

TIMBER STAND IMPROVEMENT

Release: Spruce and Pine release 20 Acres

COUNTY FOREST ROADS

Total Miles approved: 27.25
Maintenance will be done as needed on County Forest Roads.

LAND ACQUISITION

On Going
Work on trade possibilities for private interior forty.
Work on purchase of interior forty.

SURVEYING

As Required
Will work on a list of priorities with County Surveyor.

FOREST PROTECTION

- A. Implement Gypsy Moth Plan.
- B. Monitor Jack Pine Budworm and pockets of oak decline. Watch for signs of Emerald Ash Borer activity, oak wilt, red pine pocket decline and annosum root rot.

- C. Control exotic invasive plant species such as garlic mustard.
- D. Educate user groups on invasive species.

FISH AND WILDLIFE PROJECTS

County Conservation:

- A. Continue to renovate and maintain wildlife openings and connecting trails on the County Forest. Long term goal is to prioritize and better manage forest openings.
- B. Continue work on Signing and Access/Landing Improvements on Small Lakes.
- C. Continue to update and replace County Forest signage.

Wildlife Habitat:

- A. Ruffed Grouse Project Areas
 - *Trail work, gating, signing and mapping.
 - *Completed trail work improvements near Whisky Bill Road.
 - * Will monitor existing ruffed grouse areas and construct additional trails along Poplar Road and north of 4-Mile Road when the demand for additional trails develops followed up by gating.
 - * Utilize the use of DNR wildlife resources for grouse trail and other wildlife habitat development or enhancement.
- B. Forest Openings Maintenance and Improvements, including mowing hunter walking trails in conjunction with openings.
- C. Any Combination of Release; tag alder, oak or green cover.
- D. Green Cover Planting along trails.
- E. Wild Rice planting and waterfowl improvements on the Harrison Flowage. This includes signing.
- F. Alder shearing if winter conditions are favorable.
- G. Gating and access projects.
- H. Wildlife opening improvements (backhoe and dozer) as time and equipment availability allows.
- I. Any Other Meritorious Fish and Wildlife Projects.
- J. Site prep. For early successional species such as oak and birch.

RECREATION AREAS

- A. Recreation Trails: *On Going Programs (Snowmobile, ATV, Cross Country Ski, Snowshoe, Ice Age, Horse, & Mountain Bike Trails)
- B. Parks & Campgrounds: Maintenance as needed at all parks and campgrounds. Look into upgrading wells in parks and campgrounds.
- C. Boat Landings: On Going improvements to lake access.
- D. Other: Continue implementation of Lincoln County Forest Access Plan and 5-year Recreation Plan.

FOREST CERTIFICATION

Implement SFI and FSC standards and procedures.





- E. Snowmobile and ATV Rehabilitation Funding


