7. **Financial Report:** VanDeWeerd and Marheine presented the financial reports
8. **Crushing Operations**
 - a. 2015 Crushing RFP – Motion made by Vander Sanded, seconded by Pike to have VanDeWeerd go ahead with the 2015 crushing RFP and to bring it to the May meeting. All Ayes. Motion carried.
 - b. Sale of Crusher – All sides discussed, Motion made by Vander Sanded, Seconded by Plant to sell the crusher. The crusher needs to be consigned to a reputable crusher dealer for the minimum prices of: Plant and Generator set \$82,000, Breaker \$24,000 and Stacker \$18,000. Lee, Plant, Vander Sanden ayes. Pike and Koth nays. Majority vote motion carried.

13. **Recommendation to zoning to approve CUP for asphalt plant on CTH R:** Motion by Pike, Seconded by Lee to forward the recommendation to Land Services. All Ayes. Motion carried.
