Present: Marie Steffenhagen, Joan Schroeder, Sheila Pudelko, and Debbie Rauchle

Call to Order: Clerk Pudelko called the board to order at 9:00 a.m. Board of Canvasser and Debbie reviewed each precinct with the following results:

Town of Birch - Inspectors Statement: Chief Inspector’s initials missing, Municipal Clerk missed memory device number, Poll workers initials missing on incident log events.

Town of Bradley – Tally Sheets missing number of write-in totals that had no name written.

Town of Corning – Everything was done properly

Town of Harding – Inspectors Statement: Municipal Clerk missed voter unit number, Chief Inspector didn’t initial post-election tamper location.

Town of Harrison – Inspectors Statement: Municipal Clerk missed voter unit number. Zero tape had no signatures.

Town of King – Test tape should be marked “test tape” in placed with test ballots. Tally sheet – unable to determine if the write-ins for the Tomahawk School District were for the City or Apportioned areas.

Town of Merrill – Zero tape didn’t have signatures for all the wards. DS200 report and ERM report have labeled wards 1 & 2 as wards 1 & 5. Inspectors Statement: Municipal Clerk missed Memory drive number and voter unit number.

Town of Pine River – Inspectors Statement: Municipal Clerk missed voter unit number, all incidents should be consecutively numbered and include time & initials of poll workers.

Town of Rock Falls – Inspectors Statement: Municipal Clerk has labeled voter unit number the same as memory device number; they should be two different numbers.

Town of Russell – Inspectors Statement: Municipal Clerk missed voter unit number. Chief inspector didn’t list number of votes casted.

Town of Schley – Everything was done properly.

Town of Scott – Inspectors Statement: Municipal Clerk missed voter unit number, and ballot bag number.

Town of Skanawan – Inspectors Statement: Municipal Clerk area not filled out. Chief inspector's area not filled out. Tally sheet – unable to determine if the write-ins for the Tomahawk School District were for the City or Apportioned areas. Questioned whether one write-in name was missing or if the elector filled in the oval but didn't write-in any name.

Town of Somo – Inspectors Statement: Municipal Clerk missed voter unit number and used wrong number for memory device number. No chief inspectors initials. Tally Sheet – No need to hand count when using DS200 machine. Date of Election should be listed.

Town of Tomahawk – Inspectors Statement: Municipal Clerk area not filled out. Chief inspector's initials missing.

Town of Wilson – Inspectors Statement: Municipal Clerk missed voter unit number. Tally Sheet: No write-ins listed.

City of Merrill D1, Wards 1 & 2 – Inspectors Statement: Municipal Clerk area not filled out.

City of Merrill D2, Wards 3 & 4 – Inspectors Statement: Municipal Clerk area not filled out, Chief inspector area not filled out, Voter Statistics area not filled out, Incident log incomplete.

City of Merrill D3, Wards 5–7 – Inspectors Statement: Municipal Clerk area not filled out. Incident log items should be in numerical order.

City of Merrill D4, Wards 8 & 9 – Inspectors Statement: Municipal Clerk missed voter unit number, chief inspector area not filled out, and incident log not in numerical order. Ramona Pampuch received six (6) votes, which makes her the County Board Representative for District 4.

City of Merrill D5, Wards 10–12 - Everything was done properly.

City of Merrill D6, Wards 13 & 14 – Inspector Statement: Municipal Clerk area not filled out, Chief Inspector area not filled out, Incident Log has times in wrong place and there are no initials.

City of Merrill D7, Wards 15-17 – Zero Tape missing signatures. Certificate of Ballots form has the ballot count off by one too many voters. Inspectors Statement: Voter Statistics area not filled out, Incident Log missing times. Tally Sheet: Unable to determine write-ins because office type is missing.

City of Merrill D8, Wards 18 & 19 – Zero tape was missing (Later found in City of Tomahawk Wards 1 & 2). Tally Sheet: Chief Inspector didn't sign.

City of Tomahawk Wards 1 & 2 – Inspector Statement: Chief inspector didn't sign.

City of Tomahawk Wards 3 & 4 - Everything was done properly.

City of Tomahawk Wards 5 & 6 - Everything was done properly.
