- Total project costs = 3.7 mil to 47 mil. Cost is based on how many residents get full fiber.
- C3 Model is likely based on grant funding availability.

- Not everyone will need fiber based on location to tower (line of sight).

Broadband Use - Interview with Heidi O'Hare, Director

Summary submitted by Pat Voermans

1. **Broadband Service provider** – Technology for Educational Achievement -TEACH. It is provided through DPI. Library hours are 10AM-7PM but Wi-Fi is available 24 hours. Some have been in the parking lot at 2:00 AM to use it.
2. **What main geographical areas do you cover in Lincoln County?** Tomahawk, Bradley, Irma, Harrison, Nakomis
3. **How many computers in the library do you have for public use?**
Five. Most people bring their own laptops. Wi-Fi use has increased, almost double. Many use the parking lot as well. There were 9,282 uses of it in house in 2023.
4. **What is your estimate of volume of/or time the public uses your computers?** There were 25327 users for the web site in 2023. In 2023 there were 1,227 Tomahawk City users and 2,809 non city users. Usage varies from five minutes to four hours. Usage may increase when the ACP program ends at the end of April.
5. **What do you see as the main reasons the public seeks computer services at the library**
 - Affordability/Equipment –Most people that come here have their own laptops and know how to use them. Interestingly, a number of users come in to download material which saves data on their plans and also to use printers. Printers and ink are costly. Charges are 0.15 cents per one side of sheet, 0.30 cents a page and \$1.00 per page for color.
 - Lack of internet access – Out-of-towners use Wi-Fi and computers.
 - Lack of digital skills – If we had a service more people would probably seek it. We have a private room that could be used but not the staff to conduct the service.
6. **Would it be feasible to conduct a survey among the public users?** Yes. No more than 3 questions and at a 3rd to 4th grade level. Could be tabulated at the Library.
7. **What do you see as future broadband technology needs?**
Develop a hot spot outside the library for better wi-fi and phone chargers. One spot in the parking lot and one out in front where it is open and visible.
Home computers and reliable community computer hubs. For example, solar powered that could be put in public places. Solar powered bench with built in phone charger and wi-fi.
Need workspace and/or rooms for one to six people for rooms with wi-fi to use four to six hours/day (requests in summer).
