GENERAL REQUIREMENTS:

- Must be held in a location which is reasonably accessible to the public.
- Must be open to all members of the public unless the law specifically provides otherwise.

NOTICE REQUIREMENTS:

- 1. In addition to any requirements set forth below, notice must also be in compliance with any other specific statue.
- Chief presiding officer or his/her designee must give notice to the official newspaper and to any members of the news media likely to give notice to the public.

MANNER OF NOTICE:

Date, time, place, and subject matter, including subject matter to be considered in a closed session, must be provided in a manner and form reasonably likely to give notice to the public.

TIME FOR NOTICE:

- 1. Normally, a minimum of 24 hours prior to the commencement of the meeting.
- 2. No less than 2 hours prior to the meeting if the presiding officer establishes there is a good cause that such notice is impossible or impractical.

EXEMPTIONS FOR COMMITTEES AND SUB-UNITS:

Legally constituted sub-units of a parent governmental body may conduct a meeting during the recess or immediately after the lawful meeting to act or deliberate upon a subject which was the subject of the meeting, provided the presiding officer publicly announces the time, place, and subject matter of the sub-unit meeting in advance of the meeting of the parent governmental body.

PROCEDURE FOR GOING INTO CLOSED SESSION:

- Motion must be made, seconded, and carried by roll call majority vote and recorded in the minutes.
- If motion is carried, chief presiding officer must advise those attending the meeting of the nature of the business to be conducted in the closed session, and the specific statutory
 exemption under which the closed session is authorized.

STATUTORY EXEMPTIONS UNDER WHICH CLOSED SEESIONS ARE PERMITTED:

- Deliberation of judicial or quasi-judicial matters. Sec. 19.85(1)(a)
- 2. Considering dismissal, demotion, or discipline of any public employee or the investigation of charges against such person and the taking of formal action on any such matter; provided that the person is given actual notice of any evidentiary hearing which may be held prior to final action being taken and of any meeting at which final action is taken. The person under consideration must be advised of his/her right that the evidentiary hearing be held in open session and the notice of the meeting must state the same. Sec. 19.85(1)(b).
- 3. Considering employment, promotion, compensation, or performance evaluation data of any public employee. Sec. 19.85(1)(c).
- 4. Considering strategy for crime detection or prevention. Sec. 19.85(1)(d).
- 5. Deliberating or negotiating the purchase of public properties, the investing of public funds, or conducting other specified public business whenever competitive or bargaining reasons require a closed session. Sec. 19.85(1)(e).
- 6. Considering financial, medical, social, or personal histories or disciplinary data of specific persons, preliminary consideration of specific personnel problems or the investigation of specific charges, which, if discussed in public would likely have an adverse effect on the reputation of the person referred to in such data. Sec. 19.85(1)(f).
- 7. Conferring with legal counsel concerning strategy to be adopted by the governmental body with respect to litigation in which it is or is likely to become involved. Sec. 19.85(1)(g).
- 8. Considering a request for advice from any applicable ethics board. Sec. 19.85(1)(h).

CLOSED SESSION RESTRICTIONS:

- 1. Must convene in open session before going into closed session.
- 2. May not convene in open session, then convene in closed session and thereafter reconvene in open session with twelve (12) hours <u>unless</u> proper notice of this sequence was given at the same time and in the same manner as the original open meeting.
- 3. Final approval or ratification of a collective bargaining agreement may not be given in closed session.

BALLOTS, VOTES, AND RECORDS:

- 1. Secret ballot is not permitted except for the election of officers of the body or unless otherwise permitted by specific statutes.
- . Except as permitted above, any member may require that the vote of each member be ascertained and recorded.
- Motions and roll call votes must be preserved in the record and be available for public inspection.

USE OF RECORDING EQUIPMENT:

The meeting may be recorded, filmed, or photographed, provided that it does not interfere with the conduct of the meeting or the rights of the participants.

LEGAL INTERPRETATION:

- 1. The Wisconsin Attorney General will give advice concerning the applicability or clarification of the Open Meeting Law upon request.
- 2. The municipal attorney will give advice concerning the applicability or clarification of the Open Meeting Law upon request.

PENALTY:

Upon conviction, nay member of a governmental body who knowingly attends a meeting held in violation of Subchapter IV, Chapter 19, Wisconsin Statutes, or who otherwise violates the said law shall be subject to forfeiture of not less than \$25.00 nor more than \$300.00 for each violation.

GO debt increased from 2015 due to the Pine Crest Project. The County issued a NAN in the amount of \$7,000,000 in 2016 and another BAN of \$2,600,000 in 2017. Since 2017 the County has not increased GO debt.

OPEB liabilities were not recorded in 2015. GASB 75, which required the reporting of OPEBs, was implemented in 2018.

The new landfill began taking on waste in 2015. Since then the footprint has grown along with the increased liabilities for closure and long-term care.

Environment

Levy Limits

State imposed operational levy increase limits are the maximum amount the county may levy property taxes on parcels within the county, which cannot exceed Net New Construction or zero, whichever is greater.

Net New Construction

Net New Construction is the metric that determines how much the county is allowed to increase the levy from year to year. Essentially, if no new construction occurred in the county, then the allowable levy increase is zero percent. Below is Lincoln County's Net New Construction over the last 6 years:

The overall 2022 budget is \$45,959,653. Payroll comprises \$19,306,078 or 42 percent of the budget.

Population Change

For counties, population change has both economic and service implications. A shrinking population can result in less economic activity which means a smaller tax base. The population in Lincoln County has been in decline since the year 2000. According to the US Census Bureau, the population has dropped 1,226 from the year 2000 to the year 2020. This represents a 4.1% decline.

Fiscal Sustainability Issues

Health Insurance Fund

On 12/31/2021, the health insurance fund has a fund balance of \$1,305,419 (unaudited) or 46 percent. A healthy fund balance should be between \$1.13 million – \$1.7 million (40% - 60% of total expenditures). In order to remain viable, the health insurance fund borrowed \$1.2 million from the general fund.

Emergency Medical Services (EMS) Fund

The EMS fund has a deficit balance of \$290,506 at the end of 2020. The result of 2021 operations is anticipated to be a small gain. Increased payroll costs due to inability of a provider to find staff has caused a smaller than anticipated gain in 2021. Emergency Medical Services are not a mandated county service and are not subject to the levy limits.

Social Services Fund

As of 12/31/2020 the Social Services fund had a positive fund balance of \$744,462 with an unassigned amount of \$238,434 after committing \$405,000 for out of home placements.

General Fund

The General Fund is healthy with an unassigned fund balance amount of \$7,210,489 on 12/31/2020. 2021 has not been closed at this point.

Pine Crest Nursing Home

Starting in 2020, Lincoln County has contracted with North Central Health Care to manage the operations of Pine Crest. Operationally, we must make sure Pine Crest can get to a sustainable level and ensure it can remain sustainable. In 2021, Pine Crest nursing home lost just over one million dollars.

Lincoln Industries

Starting in 2020, Lincoln County has contracted with North Central Health Care to manage the operations of Lincoln Industries. Operationally, we must make sure Lincoln Industries can get to a sustainable level and remain sustainable. Lincoln Industries does not receive any tax levy. In 2021 Lincoln Industries lost \$351,000.

Operational/Program Concerns

Wheel Tax

In 2021 the Finance and Insurance Committee sent an ordinance amendment to County Board to extend the wheel tax without a sunset. The County Board amended the ordinance to sunset on 12/31/22. The Wheel Tax produces a revenue of \$460,000 in the 2022 budget.

Fees/Revenues

Approve all fee increases through the budget process. Additionally review all revenues against budgeted numbers. This will assure that all department budgets are accurate and we are capturing all revenue increases as part of the budget planning process.

Cost of Living Adjustment (COLA)

In 2016 the county completed a salary study and implemented the results of that study in 2017. The results of the study helped get salaries to a more competitive level and closer to market. Over the last 5 years the county has averaged a 1.3 percent COLA. When the COLA falls below the COLA around Lincoln County, recruitment and retention become increasingly more difficult.

No Program Expansion Without Funding

No program expansion or increase in program costs should occur without sustainable funding covering direct and indirect expenses or being approved by the full county board.

Vacant Positions

One way to address the budget challenges the county faces is to not fill vacant positions. All vacant positions need to be examined to assess the impact to the county if not refilled.

Capital Improvement Projects

Highway Facility

The current highway facilities are outdated and require major repairs. Currently a new highway facility is included in the CIP budget for the year 2026.

Lincoln Industries Building (Merrill Site)

North Central Health Care has moved the Lincoln Industries operation from the Merrill site. The site may require updates to adapt to new uses.

Pine Crest

Pine Crest currently has significant current and ongoing capital needs. The capital needs will only be known once the County understands the sustainability issues facing the nursing home and the number of bed licenses needed at the facility.



AMENDMENT AND UPDATE TO THE LINCOLN COUNTY COMPREHENSIVE PLAN

WHEREAS, the County of Lincoln, Wisconsin, pursuant to Section §66.1001(4)(b) Wis. Stats., enacted Ordinance No, 2021-01-581 and formally adopted the amended Lincoln County Comprehensive Plan 2012-2021, dated December 2011; and

WHEREAS, the County of Lincoln is hereby amending the County Comprehensive Plan to update demographics, natural, agricultural, and cultural resources, housing, utilities and community facilities, transportation, economic development, land use and mapping, intergovernmental cooperation, and other changes that have occurred and to the extend the design year of the plan through the year 2031, as set forth in the amended County Comprehensive Plan; and

SUPPORTING DEVELOPMENT OF GREAT PINERY HERITAGE WATERWAY

WHEREAS, Paddle sports, including recreational kayaking and canoeing, are becoming an increasingly popular form of outdoor recreation; and

WHEREAS, the Wisconsin River extends for 420 miles through the State of Wisconsin and 52 miles virtually bisects Lincoln County, passing through both the Cities of Merrill and Tomahawk; and

WHEREAS, the Lincoln County segment of the Wisconsin River provides a variety of paddling opportunities including both rapids and calm segments; a wild, scenic, and remote feel; developed shoreline camping opportunities; and both short and long segments between access points; and

WHEREAS, Lincoln County's Five Year Outdoor Recreation Plan defines Water Trails and refers to the development of this Water Trail and also states that 80% of respondents to the 2021 ORP survey use the water in a non-motorized way (canoe/kayak/rowboat); and

WHEREAS, the trail will highlight available launch locations, travel distances between locations, and historical signage that tell the story of the river, the heritage and the people; and

WHEREAS, the development of the Great Pinery Heritage Waterway is another way to bring tourism to Lincoln County and showcase the diverse recreational opportunities found here; and

WHEREAS, Lincoln County Forestry, Land, and Parks Department manages and maintains Camp New Wood County Park along the Wisconsin River for boat access, a day use park and overnight camping; and

WHEREAS, Lincoln County Forestry, Land, and Parks Department will serve as the project owner for the Camp New Wood Launch site and support the long term maintenance of that site; and

WHEREAS, funding for project development and future maintenance assistance will come from state grants and private donations and is being organized through the Community Foundation of North Central Wisconsin; and

WHEREAS, support from at least four municipalities and/or counties must be demonstrated to be eligible for select state grants.

WHEREAS, The County of Lincoln has held at least one public hearing on this plan update and ordinance, in compliance with the requirements of section 66.1001(4)(d) of the Wisconsin Statutes, and

WHEREAS, the Land Services Committee (LSC) of the County of Lincoln, by a majority vote of the entire Committee recorded in its official minutes, has forwarded a resolution and ordinance recommending to the County Board of Supervisors the adoption of the amended Comprehensive Plan and containing all of the elements specified in section 66.1001(2) of the Wisconsin Statutes.
