#### **GENERAL REQUIREMENTS:**

- 1. Must be held in a location which is reasonably accessible to the public.
- 2. Must be open to all members of the public unless the law specifically provides otherwise.

#### NOTICE REQUIREMENTS:

- 1. In addition to any requirements set forth below, notice must also be in compliance with any other specific statue.
- 2. Chief presiding officer or his/her designee must give notice to the official newspaper and to any members of the news media likely to give notice to the public.

#### MANNER OF NOTICE:

Date, time, place, and subject matter, including subject matter to be considered in a closed session, must be provided in a manner and form reasonably likely to give notice to the public.

#### TIME FOR NOTICE:

- 1. Normally, a minimum of 24 hours prior to the commencement of the meeting.
- 2. No less than 2 hours prior to the meeting if the presiding officer establishes there is a good cause that such notice is impossible or impractical.

#### **EXEMPTIONS FOR COMMITTEES AND SUB-UNITS:**

Legally constituted sub-units of a parent governmental body may conduct a meeting during the recess or immediately after the lawful meeting to act or deliberate upon a subject which was the subject of the meeting, provided the presiding officer publicly announces the time, place, and subject matter of the sub-unit meeting in advance of the meeting of the parent governmental body.

#### PROCEDURE FOR GOING INTO CLOSED SESSION:

- 1. Motion must be made, seconded, and carried by roll call majority vote and recorded in the minutes.
- 2. If motion is carried, chief presiding officer must advise those attending the meeting of the nature of the business to be conducted in the closed session, and the specific statutory exemption under which the closed session is authorized.

#### STATUTORY EXEMPTIONS UNDER WHICH CLOSED SEESIONS ARE PERMITTED:

- 1. Deliberation of judicial or quasi-judicial matters. Sec. 19.85(1)(a)
- 2. Considering dismissal, demotion, or discipline of any public employee or the investigation of charges against such person and the taking of formal action on any such matter; provided that the person is given actual notice of any evidentiary hearing which may be held prior to final action being taken and of any meeting at which final action is taken. The person under consideration must be advised of his/her right that the evidentiary hearing be held in open session and the notice of the meeting must state the same. Sec. 19.85(1)(b).
- 3. Considering employment, promotion, compensation, or performance evaluation data of any public employee. Sec. 19.85(1)(c).
- 4. Considering strategy for crime detection or prevention. Sec. 19.85(1)(d).
- 5. Deliberating or negotiating the purchase of public properties, the investing of public funds, or conducting other specified public business whenever competitive or bargaining reasons require a closed session. Sec. 19.85(1)(e).
- 6. Considering financial, medical, social, or personal histories or disciplinary data of specific persons, preliminary consideration of specific personnel problems or the investigation of specific charges, which, if discussed in public would likely have an adverse effect on the reputation of the person referred to in such data. Sec. 19.85(1)(f).
- 7. Conferring with legal counsel concerning strategy to be adopted by the governmental body with respect to litigation in which it is or is likely to become involved. Sec. 19.85(1)(g).
- 8. Considering a request for advice from any applicable ethics board. Sec. 19.85(1)(h).

#### **CLOSED SESSION RESTRICTIONS:**

- 1. Must convene in open session before going into closed session.
- 2. May not convene in open session, then convene in closed session and thereafter reconvene in open session with twelve (12) hours <u>unless</u> proper notice of this sequence was given at the same time and in the same manner as the original open meeting.
- 3. Final approval or ratification of a collective bargaining agreement may not be given in closed session.

#### BALLOTS, VOTES, AND RECORDS:

- 1. Secret ballot is not permitted except for the election of officers of the body or unless otherwise permitted by specific statutes.
- 2. Except as permitted above, any member may require that the vote of each member be ascertained and recorded.
- 3. Motions and roll call votes must be preserved in the record and be available for public inspection.

#### USE OF RECORDING EQUIPMENT:

The meeting may be recorded, filmed, or photographed, provided that it does not interfere with the conduct of the meeting or the rights of the participants.

#### LEGAL INTERPRETATION:

- 1. The Wisconsin Attorney General will give advice concerning the applicability or clarification of the Open Meeting Law upon request.
- 2. The municipal attorney will give advice concerning the applicability or clarification of the Open Meeting Law upon request.

#### PENALTY:

Upon conviction, nay member of a governmental body who knowingly attends a meeting held in violation of Subchapter IV, Chapter 19, Wisconsin Statutes, or who otherwise violates the said law shall be subject to forfeiture of not less than \$25.00 nor more than \$300.00 for each violation.

4) Resolution 2023-04-22

Sheriff's Office Corrections Division Wage Adjustment

WHEREAS, the Lincoln County Sheriff's Office is in a staffing crisis and is currently experiencing difficulty in recruitment and retention of personnel within the Lincoln County Sheriff's Office Corrections Division, having lost 25% of their experienced personnel within the last year, citing low wage and fringe compared to other municipalities and private sector employers as their primary reason for leaving; and

WHEREAS, in contrast to the other positions grouped with the Correctional Officers and Correctional Sergeants on the Lincoln County Wage Scale, these personnel are frequently subjected to being intentionally exposed to bodily fluids by inmates, physical assaults, and other job related hazards; and

WHERAS, the 2023 Budget approved by the Lincoln County Board of Supervisors has directed the Sheriff's Office to earn \$775,000 in outside housing dollars in order to balance Lincoln County's overall budget; and WHEREAS, pursuant to Wis. Stats. § 59.54(14)(a) and § 59.54(14)(f), Lincoln County is required to provide the Sheriff a jail and the funding for the Sheriff to adequately staff the jail, to ensure the safety of the general public and the inmates under the care of the Sheriff; and

WHEREAS, in order to help fund a wage adjustment in an effort to ensure that the Lincoln County Sheriff has the requisite staffing to ensure the safety of the general public and inmates, and to achieve the revenue requirement required of the Lincoln County Board of Supervisors, the Lincoln County Sheriff's Office has identified an opportunity to provide a modest wage raise for Corrections Division personnel, allowing for a reduction in the overall number of authorized personnel, in an effort to recruit and retain Corrections personnel, without a reduction in services to the citizens of Lincoln County.

NOW, THEREFORE BE IT RESOLVED, at the recommendation of the Sheriff of Lincoln County and the Law Enforcement, EMS / Judicial, Emergency Management Committee, it is requested that the Lincoln County Board of Supervisors adopt the following pay incentive request of the Sheriff's Office to address recruitment and retention within the Corrections Division.

- 1. Reduce the total number of Correctional Officers and Corrections Sergeants from the current authorized and budgeted 21 to 20.
- Use the dollars saved from the elimination of one correctional officer position to Move Correctional
  Officers and Corrections Sergeants two steps on the current pay scale effective the first pay period
  after County Board approval. Increases will not exceed the maximum step on the grade. All fiscal
  impacts will be covered internally.

AND WHEREAS, the Lincoln County constituents talked about the positive impact of these programs and services for the community and further described the negative impact the elimination of these programs and services would have on the community;

AND WHEREAS, the Lincoln County Board of Supervisors funded the 4H program in the 2023 budget;

AND WHEREAS, the community is overwhelmingly in support of keeping all of the programs and services offered by the UW-Extension.

NOW, THEREFORE IT BE RESOLVED, that the Lincoln County Board of Supervisors orders the Director of Finance to provide funding in the amount of \$113,334 to fully restore the UW-Extension for the year remaining of 2023, and \$170,000 for the year of 2024 using funds from the American Rescue Plan Act (ARPA).

Whereas, the bulk of the senior age population in Lincoln County does not possess the financial resources that allow for them to access private long-term health care, and

Whereas, the bulk of the senior age population has lived in Lincoln County long enough to have contributed a significant amount of tax money to the public operations of the county, to wit: snow removal, road maintenance, child protective services, schools, waste disposal etc. etc.,

And Whereas, the Pine Crest facility requires more proactive maintenance as well as a regular infusion of County financial resources than it has thus far received,

And Whereas, increasing the levy limit alone may be inequitable and insufficient for funding ongoing operations, NOW THEREFORE BE IT RESOLVED, That the Lincoln County Board of Supervisors does resolve to hold a special referendum no later than August 31st, 2023 for the purpose of determining whether the people of Lincoln County desire to continue operating Pine Crest Nursing Home as a county nursing home or not and directs that the following advisory referendum question will be placed on the ballot:

Shall Lincoln County continue to seek solutions that may include ordinance fees, annual levy limit increases by individual referenda and budget re-alignments in order to continue operating Pine Crest as a county nursing home or not?

Whereas, Lincoln County real transfer fee collections over the past five years totaled \$2,050,941, of which the County retained \$410,188 and remitted \$1,640,753 to the State; and

Whereas, in 2021 the State of Wisconsin had a budget surplus of approximately \$2.5 Billion, while many Wisconsin counties struggle financially due to the ever-increasing cost of providing State-mandated and other county governmental services; and

Whereas, in an effort to financially assist all Wisconsin counties, Lincoln County requests that the State of Wisconsin amend the real estate transfer fee share formula to allow Wisconsin counties to retain 80% of all real estate transfer fees collected, with 20% to be remitted to the State.

Be it further resolved, that a copy of this resolution is sent to Governor Evers, all members of the State Legislature representing Lincoln County, the Wisconsin Counties Association and all other Wisconsin counties.

Resolution of Support for Utilization of State Surplus Funding to Offset Supplemental Payment Decreases in Fiscal Year 2022/23 and to Continue Future CPE Award Disbursements to County Owned Nursing Homes

WHEREAS, North Central Community Services Program d/b/a North Central Health Care ("NCHC"), established as a Multicounty Department of Community Programs for the purpose of administering a community mental health, alcoholism and drug abuse services program pursuant to Wis. Stat. §§ 51.42, 59.52(7) and 66.0301, administers and operates two nursing homes, Mount View Care Center ("MVCC") and Pine Crest Nursing Home ("PCNH"), on behalf of Marathon and Lincoln Counties, respectively; and

WHEREAS, in fiscal year 2022/23, Wisconsin Department of Health Services ("DHS") had approximately \$39.1 million dollars in funding at its disposal, which funding must be allocated for disbursement to county owned nursing homes in order for the State of Wisconsin to maintain eligibility for Medicaid funding; and

WHEREAS, in addition to Supplemental Payments to county owned nursing homes as described in the aforementioned paragraph, county run nursing homes traditionally received Certified Public Expenditure ("CPE") Award funds from DHS; and

WHEREAS, NCHC budgeted revenue necessary for the administration and operation of MVCC and PCNH is based on DHS' historical Supplemental Payment and Excess CPE Award disbursement amounts; and

WHEREAS, for fiscal year 2022/23, and without advance notice, DHS significantly decreased the amount of the Supplemental Payment and Excess CPE Award funding that was traditionally available to NCHC for the administration and operation of county owned nursing homes; and

WHEREAS, the total reduction in Supplemental Payment and Excess CPE Award funding is summarized as follows:

WHEREAS, in addition to Marathon and Lincoln counties, twenty-one (21) other Wisconsin counties also experienced significant decreases in supplemental payment funding, leading to budget deficits in those counties, while Dane and Rock counties received a significant increase in supplemental payment funding resulting in budget surpluses; and

WHEREAS, although both MVCC and PCNH will receive a much needed increase in Medicaid rates for standard services provided, any benefit from this Medicaid rate increase is essentially nullified as a result of DHS reduction in Supplemental Payment and CPE funding; and

WHEREAS, despite the Medicaid rate increases, the reduction in Supplemental Payment and CPE funding once more jeopardizes the financial viability and the long-term operational feasibility of county owned nursing homes.

NOW THEREFORE BE IT RESOLVED, that in order to ensure financial viability and operational feasibility of county run nursing homes, the County of Lincoln requests that the Wisconsin State Legislature to do the following:

- 1. Utilize State of Wisconsin surplus funding to fund additional disbursements of Supplemental Payments to county nursing homes to offset any previous supplemental payment decreases.
- 2. Utilize State of Wisconsin surplus funding to pay all county nursing homes CPE payments comparable to the CPE payment disbursements in fiscal year 2020/21.
- 3. Review and revise the Supplemental Payment formula to be more consistent in future years and to match historic disbursement amounts received by the counties in years prior.
- 4. Budget for the continuance of CPE funding for future years.

BE IT FURTHER RESOLVED that this resolution shall be forwarded by appropriate County officials to the Wisconsin Legislature.
