Summary of Services:

Health Information

Coordinate a System of Managing Student Health Information within the school system and maintain confidential health records for individual students receiving ongoing school nursing services.

Special Health Care
Needs

Provides Services for students with Special Health Care Needs.

Communicable Disease

Provide communicable disease control and promote compliance with the Wisconsin Immunization Requirements.

Emergency Nursing

Assist in development and implementation of a plan for Emergency Nursing Services in the schools, including staff training and delegation, medication administration, triage, injury care, referral and follow up.

Screening

Participation in the Hearing and Vision Screening process and follow up.

Appraisals and Referrals

Provide confidential physical, mental, and psychosocial health appraisals, health counseling and referrals for care and follow up to students.

Health Education

Provide health education for students, families, and school staff members both individually and collectively, to promote healthy life styles and responsible decision-making regarding matters affecting health and wellness, including human growth and development.




The school setting is where school nurses work to keep students in school, managing student's chronic health conditions so they can be in the classroom learning. Of the 2105 Student Health Office Visits:


- 1705 went back to class
- 343 went home ill
- 57 were referred to a provider
- 911 was called 0 times during the school year by nursing staff.

Individual Health Plans (IHPs) and Medications



<u>Individual Health Plan:</u> A carefully prepared outline of nursing care showing all of the students' needs and the ways of meeting them while keeping them safe in school; a document that is subject to continuous reassessment and change by the nurse; typically includes nursing diagnoses, nursing interventions, and outcomes; ensures consistency of care. The plan is developed with the interdisciplinary collaboration of the school staff in partnership with the student's family, the student and the student's medical provider.

Outbreaks



During the 2022-2023 school year there was a unique triple outbreak of COVID, influenza, and respiratory syncytial virus (RSV) in the fall. This lead to large amounts of absenteeism due to illness and quarantine.

Additional outbreaks seen at the school with school nursing staff were chickenpox and hand foot and mouth disease, which share many similarities to chickenpox in presentation. The school nurse served as a coordinator of communication and education between the schools, families, staff and local medical clinics.



Students are compliant with the immunization law if they meet all of the minimum immunization requirements, are considered "in process", or have a waiver on file. MAPS will again have to exclude those grades K-5 who are not compliant due to not obtaining the required 99% compliance rate.

HEAT Teams

Emergency nursing services are an important piece of the school nursing program and implementation of policies and plans are vital to quality services for our students. HEAT (Health Emergency Activation Team) delegation is an important part to school services where the nurse trains staff on emergency plans in relation to the school health needs for that school year. MHS and PRMS staff have utilized the activation of the HEAT team to get immediate response to assist in known and unknown health conditions throughout the 2022-2023 school year.

Updates to School Health Program

In 2022-2023, Lincoln County Health Department assisted MAPS in updating and or creating policies/guidelines/Memos/Forms/Exhibits, which included:

- School Nursing certification in Suresight vision screening
- School Nursing training in Skyward
- Human Growth and Development Curriculum Changes and Coalition meetings
- Restructure PRMS Health Office including more efficient student triaging.
- Installed eye wash station at PRMS
- Implementation of Diabetic Health Aides at PRMS
- Implementing field trip medical bags for health plans and medications
- Standardization of documentation between nurses of student health information
- Increased collaboration with school social workers and counselors

Summary of School Health Program

Through the provision of comprehensive and direct health services, school nurses strengthen and facilitate the education process by reducing or eliminating barriers to accessing health care. School nurses have expertise in clinical nursing, communication, surveillance, education, advocacy and leadership in order to ensure that all students' health needs may be addressed. The school nurse has the educational background, experience, and competency to oversee the coordinated school health program.

During the 2022/2023 school year, MAPS received quality care for its many students with health conditions. As noted in the report, almost 200 students have individual health plans and many more have health conditions that affect them during the school day. In having school nursing staff, each school is able to have their staff trained and prepared to handle the increasingly difficult medical needs of students. There is a wide variety of students with high medical needs within the district and through the nursing staff, each of those students are able to come to school in a safe and healthy environment. The school nurses view their relationship with the District not as employees but as a trusted caretaker of the health and wellbeing of MAPS staff and students.
