An operating without a license fee will be issued for all facilities that are operating without a current license. A re-inspection fee will be assessed based on the license								
category for any required re-inspection.  Within <b>30 days</b> after receiving a complete application for a license, the department or its agent shall either approve the application and issue a license or deny the								
application. If the application for a license is denied, the department or its agent shall give the applicant reasons, in writing, for the denial.
