The County Board of Supervisors of Lincoln County, Wisconsin, does hereby ordain:

Pursuant to section 59.69, 59.692, 59.694 and the requirements in 87.30 of the State Statutes, the County of Lincoln is authorized and required to prepare and adopt a zoning ordinance that governs all floodplains that are located outside of incorporated cities and villages within the boundaries of Lincoln County. By enacting this ordinance, Chapter 20 of the Lincoln County Code of Ordinances dated May 19th, 1998 is hereby repealed and re-created as attached.

This ordinance shall take effect August 16, 2011, from and after its passage and publication.


**HARRISON LAKE

 — 100-YEAR DAM FAILURE





