- 9. <u>Survey Grade Network RTK GNSS Receiver and Hardware/Software RFP Update and Request for Purchase</u> Huth and Dallman updated the committee that no bids were received for the RFP. They presented a previous quote that was received for the equipment and requested permission to purchase the necessary items.
  - M/S DePasse/Detert to approve Land Services to purchase the Survey Grade Network RTK GNSS Receiver and Hardware/Software. Discussion occurred. Motion carried on a voice vote.

- 11. <u>4:00pm Public Hearings</u> Public Hearing was called to order at 4:00pm by Chair Lemke. Lemke explained the rules of conduct for public hearings and introduced the Committee members and staff. Lemke further explained that items a and b will be discussed simultaneously.
  - a) A request by Lonn Monte Lamer and Shirley Mae Lamer Joint Revocable Trust to amend the Lincoln County Comprehensive Plan Map from Residential (Rural Single Family Residential) to Non-Residential (Planned Business) for a portion of tax parcel pin# 00435061119998. The property is located in Section 11, T35N-R6E, in the Town of Bradley.
  - b) A request by Lonn Monte Lamer and Shirley Mae Lamer Joint Revocable Trust to rezone a portion of tax parcel pin# 00435061119998, from Rural Residential-2 (RR2) to Planned Business (PB). The property is located in Section 11, T35N-R6E, in the Town of Bradley. The request is being heard under section 17.8.25 and relating to sections 17.2.51 and 17.2.31 of the Lincoln County Zoning Ordinance.

Lemke asked for testimony in support of the request. Lonn Monte Lamer, the applicant, was present and explained the requests. There were no questions.

Lemke asked for additional proponents of the request. There were none.

Lemke asked for testimony from opponents of the request. Gregg Jozwik, Sheila Jozwick, Roy Schlachtenhaufen, Janele Schlachtenhaufen, and Mary Cavala (sp?) spoke in opposition of the request expressing concerns regarding lake health, business use of the property, continued potential rezones, proximity of homes to business districts, traffic safety, potential reduction of property values, and future generational use of the properties in their current state.

Huth entered into the record the correspondence/letters, which were received after the packet distribution but prior to the public hearing.

Huth presented the staff report and informed the committee that the Town of Bradley requested a 60-day extension in order to file the recommendation. County staff recommends that the committee approve the requests, as written in the staff report, once the Town recommendation is received. Discussion occurred.

M/S Bialecki/DePasse to approve the 60-Day extension as requested by the Town of Bradley. Motion carried on a voice vote.
