\*The request for your social security number is pursuant to the Social Security Law, 42 USC Section 405(c)(2)(C) and Wis. Statute 71.935 for the purpose of an income tax intercept, if you are convicted and you fail to pay the amounts ordered. The social security number is given voluntarily unless there is a mandatory requirement – such as if you do not have your driver's license with you.

## Did you know that .....?

- A 2-year suspension of your driving privileges or jail does not replace the dollar amount of the fine you owe. You still have to pay the money!
- A citation for driving while your license is suspended is \$200.50 or more.
- You will have to pay the Department of Motor Vehicles to reinstate your driving privileges if a suspension has taken place.
- The Clerk of Circuit Court is authorized to issue a warrant for your arrest for failure to pay your fine.
- The Clerk of Circuit Court can issue a civil judgment against you for unpaid fines/forfeitures/financial obligations. A civil judgment against you affects your ability to obtain a loan and/or sell property.
- The Clerk of Circuit Court is authorized by statute to add 12% interest to your unpaid fines/forfeitures/financial obligations annually.
- A wage assignment may cost you an additional \$3 per paycheck if your employer is ordered to seize your earnings in payment of your fine.
- The Clerk of Circuit Court can intercept your Wisconsin state income tax refund for your unpaid fines/forfeitures/financial obligations.
