AMC Updates	Group	There are 2 youth that have been referred to court from Tomahawk and 6 youth from Merrill. Kristopher Ellis, DA will be on all truancy cases. DA would like to see first 4 steps done before being referred to their office and make sure that the student acknowledges this is a problem and the parents have been contacted. The Probate office has to give a 10-calendar day notice by statute. Sofia will file under the case # OR “cc” the Public Defenders office and DA’s office. There is a lot of documentation on the school’s end. Tomahawk would like Judge Russell to talk to the student/parents. This is being missed and was very beneficial in the past.
