#### Assumptions/Remarks:

In our proposal dated April 19, 2023, we allotted for \$8,500 for preparing the project manual and providing construction assistance, if needed, for intermediate cover construction. After the proposal was submitted, TRC and the landfill manager discussed the rate of filling and accelerated the needs for new cell excavation and clay haul activities, increasing the required scope of work for TRC's 2023 general assistance. The out-of-scope tasks provided below include construction-focused and other general assistance tasks that TRC has performed and proposes to perform in the remainder of 2023.

# 2023 Construction Tasks (Completed):

TRC has provided the following out of scope items related to construction activities:

- Increase in scope of the project manual, including contract documents, specifications, and figures for the following construction activities:
  - Sedimentation basin repair.
  - Phase 4 Module 2B excavation to subbase elevations.
  - Northeast road relocation.
  - Associated clearing, grubbing, and erosion and sedimentation controls.

- Preconstruction meeting with WDNR to inform them of construction plan and schedule.
- Issue bid documents to pre-qualified bidders and lead July 19, 2023 onsite pre-bid meeting.
- Prepare and submit project manual Addendum 1 to bidders.
- Support landfill manager for bid opening meeting, review/tabulate bids, coordinate signatures of contract documents upon notice of award.
- Coordinate surveys for conditions preconstruction, after waste-grading, and at substantial completion. Provide DTM surfaces to surveyor and contractor.
- Prepare isopach drawing for Phase 4 Module 2B excavation.
- Prepare and submit project manual Addendum 2 to selected contractor.
- Review and respond to contractor submittals.
- Lead August 22, 2023 onsite preconstruction meeting.
- Provide regular office support with landfill manager and contractor to during construction.
- Communicate with landfill manager and contractor regarding trash and debris in stockpiled intermediate cover soils. Inform WDNR of plan to use clean C-Soils and pick windblown trash.
- September 5, 2023 site visit to observe construction progress, classify soils to be used for intermediate cover, and evaluate debris in placed cover soils.
- Revise project drawings and coordinate geometry for northern extension of intermediate cover on the eastern slope.
- Coordinate EEC-8 extension requirements with contractor and landfill manager.
- September 27, 2023 site visit to observe seeding, stormwater management, and construction progress at substantial completion.
- Prepare construction stormwater logs.
- Coordinate solution to repair intermediate cover near Phase 4 Module 2A Vault.

#### 2023 Construction Activities (Ongoing & Future):

TRC is currently performing and proposes to perform the following out of scope items to complete construction.

- Review of contractor applications for payment. Compare to quantities from survey.
- Construction completion contracting support.
- Update project existing conditions drawings and coordinate geometry tables.
- Prepare construction summary for 2023 Annual Assessment Report.

#### Additional Out of Scope Tasks:

The following tasks are out of scope of TRC's original proposal that need to be completed prior to January 1, 2024, and are not directly associated with the 2023 construction activities.

- Estimate remaining airspace in active landfill area (Ongoing).
- Prepare estimates for Premature Closure Costs and Long-Term Care Costs (Ongoing).

- September 27, 2023 site visit to Drew Farm clay borrow site with landfill manager (Completed).
- Evaluate potential clay borrow source at Gary Thomas Farm.
  - Review available data from landowner (Completed).

  - Limited laboratory testing scope (Ongoing).
- Initiate work on upcoming clay haul, Phase 5 rephasing, and needs for expansion (Ongoing).
- Miscellaneous support for future tasks identified by Lincoln County staff, up to \$5,000.

## **Equipment Update**

We have some aged equipment here that is worked quite hard.

Our compactor, 1996 Cat 826G was last rebuilt in 2014, it has 23,750 hours on it now.

Our Track Loader was purchased in 2009, it has been partially rebuilt multiple times. 42k in 2016, 18k in 2018, 42k in 2022.

Both of the above are having issues currently.

We have a 1999 loader, IT28g that should be replaced as well.

We do not need to replace items with new equipment - newer/rebuilt machines are fine.

We have an air powered actuator that could be upgraded to all electronic.

If there is a possibility ARPA funds could be a solution I would like to explore it.
